New York has launched its first bulk energy storage RFP, seeking 1 GW as part of its 6 GW roadmap. The NYSERDA-led program targets cost savings, grid reliability, and early adoption of updated safety codes.

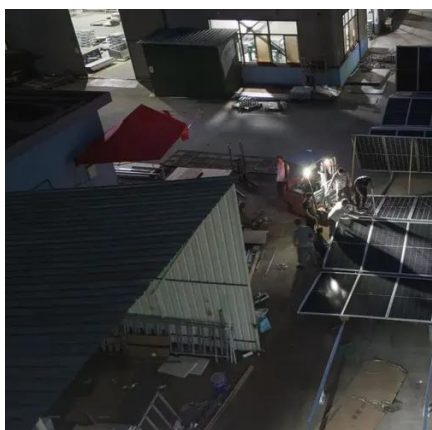

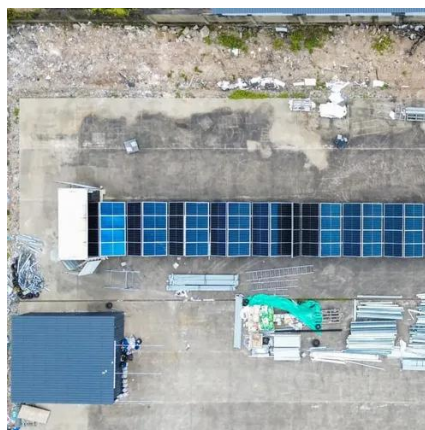
