On March 6, 2025, the Georgia House Legislature introduced House Bill 249, a significant piece of legislation aimed at regulating solar power facility agreements within the state. The bill seeks to establish clear guidelines for the operation and management of solar energy devices on leased.

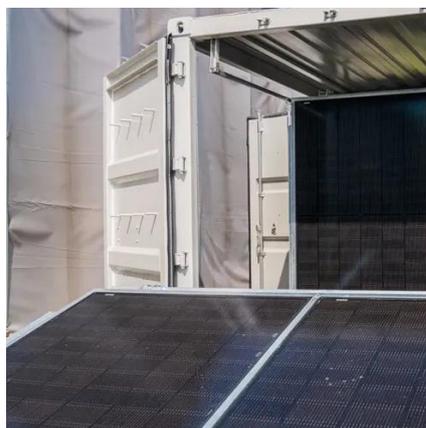


