The rules for importation are contained in Code Of Federal Regulations Title 47. Part 2, Subpart K - Importation of Devices Capable of Causing Harmful Interference. Section 2.1204 of Part 2 Subpart K defines the 11 conditions that radio frequency devices may be imported.

Can a medical implant transmitter be imported without a grant of equipment authorization?

Such transmitters are permitted to be imported without the issuance of a grant of equipment authorization only for the personal use of the person in whom the medical implant transmitter has been inserted or on whom the medical body-worn transmitter is applied.

How is a radio frequency device approved by the FCC?

The radio frequency device has been issued an equipment authorization by the FCC. The equipment has been approved per the required equipment authorization procedure (e.g., Certification or Supplier's Declaration of Conformity (SDoC)) for the device being imported.

Who is responsible for obtaining overseas customs clearance of FMS/BPC materiel?

The FMS customer country or BPC case recipient country is responsible for obtaining overseas customs clearance of all DTS-routed FMS/BPC materiel through its customs agencies for receipt of the materiel at the foreign port of discharge. 


