Incentives for all residential and retail storage projects are provided through a network of participating contractors approved under the Residential and Retail Energy Storage Incentive program who contract directly with the customer. Incentive details will be available on the Residential Energy Storage Incentive Dashboard and Retail Energy Storage Incentive Dashboard. The Residential Energy Storage Incentives are available for contractors' installing storage on a new or existing home in New York State. Incentives are available for up to 25 kWh of storage capacity.

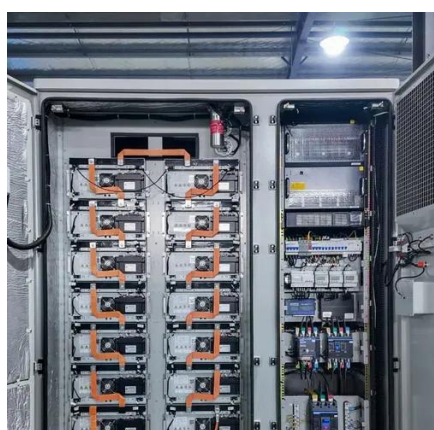
