The French Ministry of Ecological and Solidarity Transition recently finalized the sixth bidding.

Recently, France's Ministry of Ecological Transition has completed the 9th round of rooftop solar tenders, which falls under the framework of the 6th PPE2 (Multi-Year Energy Programming). Originally planning to tender 400MW, only 220.3MW of



installed capacity was ultimately awarded to 54 projects.
