This credit applies through 2032, with a reduction to 22% by 2034. For example, a typical home energy storage system can save homeowners between \$3,000 and.

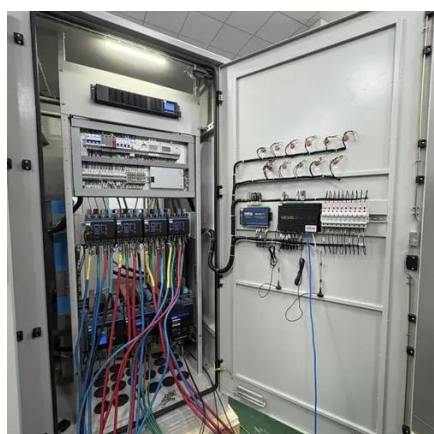
