The Distribution Companies are seeking to procure approximately 1,500 MW of Mid Duration Energy Storage Systems. This is the first solicitation pursuant to Section 83E and it is part of a staggered procurement schedule developed by DOER, in coordination with the Distribution Companies, in accordance with the authority granted to DOER.

When will long-term contracts for energy storage projects be released?

The exact release date for the Long-Term Contracts for Energy Storage Projects remains "TBD," though a tentative schedule in the draft suggests a public release of the RFP on July 31, 2025. The RFP includes scheduled periods for questions and feedback through the fall, with proposal submissions due by Sept. 10.

Does Massachusetts have a long-term contract for energy storage systems?

July 31, 2025 The Massachusetts Electric Distribution companies, in coordination with the Massachusetts Department of Energy Resources, issued an RFP for Long-term Contracts for Energy Storage Systems and associated Environmental Attributes pursuant to Section 83E of Chapter 169 of the Acts.

What is Massachusetts' energy storage procurement?

The energy storage procurement aligns with Massachusetts' 2024 legislation, An Act Promoting a Clean Energy Grid, Advancing Equity and Protecting Ratepayers, which directs the state to procure energy storage totaling 5 GW by July 31, 2030. The procurement targets 3.5 GW of mid-duration storage (four to ten hours), totaling 14,000 to 35,000 MWh.






Parallel (Parallel operation up to 6 unit (only with battery connected))
